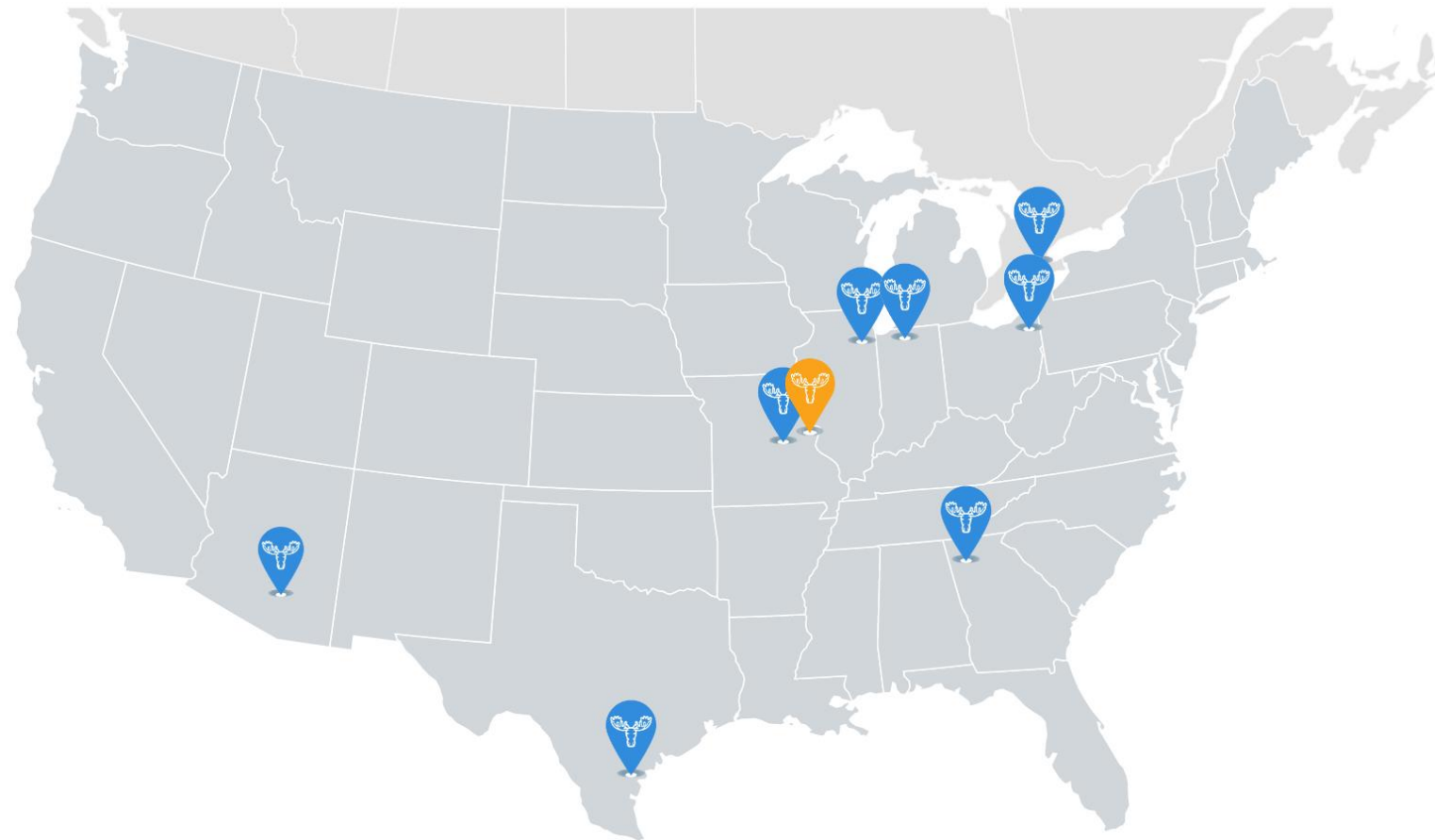

# Minimum Insurance Requirements

- General Liability
  - Bodily Injury – General Aggregate \$2,000,000
  - Bodily Injury – Per Occurrence \$1,000,000
  - Property Damage – General Aggregate \$2,000,000
  - Property Damage – Per Occurrence \$1,000,000
- Automobile Liability
  - Combined Single Limit \$1,000,000
- Workers Compensation Statutory
- Employer’s Liability Protection \$1,000,000
- All Trucking and Freight Vendors
  - Motor Truck Cargo \$100,000
- All Trucking and Freight Brokers
  - Contingent Motor Truck Cargo \$100,000

# Accessorial Schedule

- Standard Tarp charge - \$75.00
- Over Length Tarp Charge - \$100.00
- Flat Stop Charge - \$75.00 (*Subsequent to the 2nd stop*)
- New York City Surcharge - \$150.00
- TONU (*Truck Ordered Not Used*) Charge - \$250.00
  - *Prior Written Approval Required.*
  - *Defined as a cancellation of the load by BMT for extenuating reasons and payable only if the driver is physically on site at the pickup location.*
- Layover Charge - \$200.00
  - *Prior Written Approval Required.*
  - *Defined as a charge calculated: Delivery appointment time - physical arrival time at receiver - Driver Not Unloaded at the end of the business day of the set appointment day.*
  - *Driver compelled to layover overnight for unloading > appointment day*

- Standard Rate Per Hour - \$50.00
- Maximum Rate Per Load - \$400.00
  - *Detention is payable if the driver arrives **ON TIME** for for his/her appointment. If arrival is prior to/at appointment time, the clock begins from the **appointment**.*
  - *Two hours of loading time is **allowed** at all Bull Moose facilities. **Some loads require > 2 hours.** Prior communication will take place for loads requiring > 2 hours loading time.*
  - ***Detention = Loading Completed Time – Appointment/Truck Arrival Time – 2 hours.***
  - *Bull Moose **DOES NOT PAY** detention at the **Consignee/Receiver**.*
- Carriers are required to submit detention request within 24 business hours from time occurrence. Detention requests submitted out of the time window will be rejected.
- Bull Moose has 24 business hours from receipt of the original dententon request for review, accept and or deny detention.
